Entry Fee & Event Eligibility:

The entry fee is \$75.00 per participant. Players are allowed to participate in maximum of 3 events. The three events entered cannot span more than two age groups. If same events in multiple age groups are entered, only the lower age group event qualifies for ranking points. Withdrawals and refunds are not available after the registration deadline for this tournament.

- Players younger than those eligible to play in U11 are not able to participate (in other words, only players born in 2004 or 2005 should play in the U11 age group).
- Players are allowed to play in two of the same event and another, different, event. They may not span more than two age categories.

Events: Boy's Singles, Girl's Singles, Boy's Doubles, Girl's Doubles and Mixed Doubles.

Age Division: To qualify for an age division, the player's age must be under the age limit as of 12/31/14.

UNDER-19 (born year 1996 and later)

UNDER-17 (born year 1998 and later)

UNDER-15 (born year 2000 and later)

UNDER-13 (born year 2002 and later)

UNDER-11 (born year 2004 and later)

All events cannot span more than two age groups

U13 BS + U15 BD + U15 XD = OK

U13 BS + U15 BD + U17 XD = NOT OK

Only the lower age group event qualifies for ranking points if same events in multiple age groups are entered

U13 BS + U15 BS + U13 BD = U15 BS will be non-ranking

U15 BS + U15 BD + U17 BD = U17 BD will be non-ranking

Eligibility:

Participants must be legal US residents and active USAB members (non-members may join before tournament). Annual USAB membership can be obtained at www.usabadminton.org

Conditions:

1. YONEX tournament grade shuttles will be used throughout the tournament.
2. A consolation draw will be held for players who lose their first match in a given event.
3. Events with not enough entries may be cancelled.
4. All matches will be the best of three games to Badminton World Federation (BWF) 21 points with rally-point scoring system (both main and consolation draws).
5. A player not ready to play 10 (ten) minutes after his/her match is called may be defaulted.
6. Each Player in a doubles partnership must submit separate entry forms.
7. Acceptable badminton clothing must be worn during play. Doubles partners are encouraged to wear matching colors.
8. The tournament committee reserves the right to change any of the above conditions.
